

4-H Horse & Pony Arena Permit

RULES FOR USING 4-H FAIRGROUNDS HORSE ARENA

1. The purpose of these rules is to bring order and safety for those who are using the 4-H arena.
2. A parent or legal guardian must accompany any 4-Her(s) the entire time the 4-Her has a horse present on the 4-H grounds. If the parent/legal guardian must leave for any reason 4-Her(s) must leave also. Past and present committee members who have signed ABE form 785 on file in the 4-H office may supervise 4-Hers other than son/daughter.
3. Only 4-H Horse & Pony members shall ride, drive, or lunge their horse at the fairgrounds. Exception: In the interest of safety the 4-Her's parent/legal guardian may ride, drive or lunge a 4-Her's horse or pony.
4. Any horse or pony being used must be that 4-Her's 4-H enrolled animal. No stallions are eligible for 4-H except during calendar year foaled.
5. Parents/legal guardians of the 4-Her may ride in the arena, but will have to have their own medical insurance.
6. Riding and driving allowed in horse and pony arena and make-up area only.
7. No bare-back riding. No riding double.
8. No smoking in the barn.
9. No alcoholic beverages are allowed on the fairgrounds.
10. American society for Testing and Materials (ASTM) standard F1163 certified helmets are strongly recommended for all riders while practicing.
11. The fairgrounds will be left as it was found: equipment removed from arena, arena and barn lights turned off, gates shut, trash picked up and disposed of properly, and manure picked up or scattered in grassy areas.
12. When using the 4-H arena you must be able to produce the "Arena Permit" to show the fairgrounds superintendent that you have been approved to use the arena.

4-H FAIRGROUNDS HORSE ARENA PERMIT

Oct. 1, 2009 – September 30, 2010

You must obtain permission to ride in the Dubois County 4-H Horse & Pony Arena.

To obtain permission, this form must be completed and signed by the 4-H member and both parents or legal guardian. Return the form to the Extension Office before wanting to ride the arena for the first time. 4-H membership will be confirmed (You must have a signed 4-H enrollment form for the current 4-H year on file in the Extension Office).

The form will be signed by an Extension Educator. The Extension office will keep the original and return a copy to you. This permit will only allow the 4-Her(s) to use the arena during the current 4-H year.

Signature of this permit designates that the "signed" has read the "Rules for Using 4-H Fairgrounds Horse Arena", consents to all provisions, and also agrees to abide by the rules. This is your warning. When the rules are broken the privilege of using the 4-H Arena by the involved persons will be withdrawn immediately.

When signing for your child to use the Dubois County 4-H Horse & Pony Arena you agree that a parent/legal guardian will chaperon your child/children the entire time your child/children are on the fairgrounds. Any 4-Her without parent/legal guardian present will NOT be allowed to use the arena. If parent/legal guardian must leave for any reason 4-Her(s) must leave also.

It is agreed that Dubois County 4-H, the 4-H Horse and Pony Committee and Leaders and the Indiana 4-H Program assumes no liability for loss to property or by reason of any claim for personal injury, including death. We herein release and discharge Dubois County 4-H, the 4-H Horse and Pony Committee and Leaders and the Indiana 4-H Program, their component members, and their successors from liability by reason of injury or property, and/or persons, including each death, which may occur within or upon the Dubois County 4-H Fairgrounds connected with the use thereof:
